Foster Care Board Payment Schedule

Foster board and childcare subsidies are issued the second Thursday of the month following the date of service. Below is the reimbursement schedule for the next six months.


- January services reimbursed Feb. 13
- February services reimbursed March 13
- March services reimbursed April 10
- April services reimbursed May 8
- May services reimbursed June 12
- June services reimbursed July 10

Don't Forget to Complete Your Medication Logs

Caregivers, we need your help to achieve compliance with psychotropic medication requirements.

Case managers are required to review and obtain medication logs (maintained daily) at

Car Seat Safety: Check the Date

To promote the safety of children placed in our foster homes, the licensing team is required to check for car seat expiration dates during their quarterly and licensing visits. Please check the expiration dates for car seats used in your home. Those dates are usually found on labels located on the bottom or side of the seat.

If your car seat is expired, take advantage of Target's car seat trade-in program. It allows you to drop off your expired car seat with discount eligibility toward the purchase of a new seat. This service usually happens twice per year. Details can be found on the <u>Target website</u>.

If you need help installing a car seat, check with your local fire department.

Camera and Recording Guidance

We have received new guidance from the Department of Children and Families that cameras are no longer required to record. If a camera does record, the footage still needs to be kept for 14 days. Cameras are not allowed in bedrooms or bathrooms.





Report Mid-year Changes

While the items below have always been required, the state will be audited by the Federal government beginning late this year for compliance tied to federal IV-E funding. Please notify your relicensing and support coordinator immediately to report any of the following changes to your household so we can help keep your home in compliance with code requirements:


- New household members. Any individuals ages 12 and older must be background checked immediately. If you know in advance that someone new will be living in your home, the licensing team will work to process their background screening in advance to prevent your license from being out of compliance. Having any adult living in your home who has not been background screened can impact placement of children in your home until the background checks are completed.
- Renovations to your home.
- Changes in sleeping arrangements, such as adding or removing beds in rooms.
- Marriage or divorce.
