#### Court Ordered Reunification or Change of Placement: How it Affects You

When a judge orders reunification or a change of

placement, the change is effective the date the court order is signed, unless the order specifies otherwise. Legally, the child is no longer placed in foster care, which affects the ability to seek medical care for the child if needed. And FPOCF is not able to pay room and board after the court-ordered move date. If you encounter a situation where a judge has ordered a placement change and you are asked to keep a child longer, please alert your relicensing and support coordinator of the situation.

#### Foster Care Board Payment Schedule

As we have shared previously, foster board and childcare subsidies are issued the second Thursday of the month following the date of service. Below are the

payment dates for the remainder of this year:

- September services reimbursed Oct. 10.
- October services reimbursed Nov. 14.
- November services reimbursed Dec. 12.
- December services reimbursed Jan. 9.

#### On Call Support

The foster home/caregiver support line has merged with the intake and placement on-call line. For all support needs after hours and on weekends, call **321-300-0466**.

#### **Reporting Mid-year Changes**

While the items below have always been required, the state will be audited by the federal government beginning late next year for compliance tied to federal IV-E funding. Please notify your relicensing and support coordinator immediately to report any of the following changes to your household so we can help keep your home in compliance with code requirements:

- New household members. Any individuals ages 12 and older must be background checked immediately. If you know in advance that someone new will be living in your home, the licensing team will work to process their background screening in advance to prevent your license from being out of compliance. Having any adult living in your home who has not been background screened can impact placement of children in your home until the background checks are completed.
- Renovations to your home.
- Changes in sleeping arrangements, such as adding or removing beds in rooms.
- Marriage or divorce.

#### Sunshine Health Accepted at More Pharmacies

Sunshine Health is now accepted at CVS, Walgreens and Publix pharmacies. And have you used the over-the-counter benefit this month? Through Sunshine Health, each participant can receive up to \$25 worth of over-the-counter items every month. Use this benefit to purchase items like baby wipes, vitamins and Tylenol tablets. You can also get everyday items like laundry detergent, soap and toothbrushes. Visit the **Sunshine over-the-counter web page** for details.

In our September foster parent spotlight, Katrina and Frederick Williams have been recognized by the GAL and case manager for the kids placed in their home:
